



## **Monthly Report – July 2025**

### **Executive Summary:**

In this reporting period, our Mission continued to fulfill its commitment to serving the most vulnerable members of our community through targeted assistance and compassionate outreach. We responded promptly to urgent medical and nutritional needs, demonstrating both agility and empathy in our support. Our efforts this month focused on direct food relief and critical healthcare intervention, reaffirming our values of dignity, care, and solidarity with those in crisis.

### **1. Key Activities and Support Provided:**

#### **1. Food Assistance:**

- The Mission provided 3 food boxes weighing 102 lb. for three different struggling families with an average of five persons per family, addressing basic nutritional needs in the community. Each box contained essential staples such as rice, lentils, canned goods, and essential food items, helping to alleviate food insecurity and provide short-term stability for these households.



## 2. **Medical Aid:**

- A third request this year from cancer patient Ms. Yollande Mezher for urgent financial assistance was swiftly addressed by our team. Bringing the total assistance to \$450, this covered the cost of a critical radiotherapy session. We ensured Ms. Mezher received the life-saving treatment she urgently needed, demonstrating our continued commitment to supporting individuals facing serious health crises.

## 3. **Impact on Beneficiaries:**

The assistance provided this month had a tangible and immediate impact on the lives of our beneficiaries. The food support offered relief to families experiencing financial hardship, helping them preserve dignity and avoid hunger. MS. Mezher's successful access to radiotherapy not only prolonged her life but also provided emotional support and hope during a time of great distress. These actions reinforced trust in our Mission's responsiveness and reliability, enhancing our reputation within the community as a source of real and meaningful help.

This period highlighted several ongoing challenges, including limited resources to meet increasing demands. The growing number of requests for both food and medical assistance is stretching our operational capacity.
